#### **TERMS & CONDITIONS:**

**DEPOSITS/FINAL PAYMENT:** A deposit of \$600 per person is required to secure a reservation. A 2<sup>nd</sup> deposit of \$1000/p is due March 1, 2019. A 3<sup>rd</sup> deposit of \$1500 p/p is due January 3, 2020. Final Payment is due no later than June 9, 2020.

**DEVIATIONS:** Any requests for deviations must be in writing and received by MWT Associates, Inc. no later than Feb 1, 2020 and subject to air availability. There is a non-refundable \$200 per person deviation fee must be paid prior to any arrangements, plus, any additional expenses incurred for airfare itinerary.

**DOCUMENTATION:** A passport valid up to six months after your return date is required to all travelers to Argentina and Chile. A Tourist card will be issued in Chile.

**TRANSFERS:** Transfers are provided if airfare is purchased through MWT Associates, Inc. If own air is arranged, transfers may be pre-purchased.

**AIR TAX:** Any additional air increase or fees will be added at final billing: 06/09/2020.

**AIR CREDIT:** \$1000, international air only. The interior air is included.

**CANCELLATIONS AND REFUNDS:** All cancellations must be in writing to MWT Associates, Inc., 1243 Park Avenue, San Jose, CA 95126 within the allotted dates listed. Once a reservation is received, there is a \$200 per person cancellation and administration fee for all reservations under deposit prior to November 1, 2018. In addition, cancellations received between November 2, 2018 – May 1, 2019, initial deposit will be forfeited. From May 2, 2019 – January 30, 2020 a full deposit will be forfeited; From February 1, 2020- July 1, 2020. 100% of fare will be forfeited.
